ELIGIBILITY CRITERIA:

Bidders should meet the following eligibility criteria to qualify for the tender:

General Terms And Conditions

TRANSACTION FEE: All the participating bidders shall pay a transaction fee (non-refundable) to M/s APTS, Hyderabad and through on line. (0.03% of estimate value + GST as applicable).It is mandatory for all the participant bidders from 1st January 2006 to pay a Non-refundable Transaction fee electronically to the M.D., A.P.T.S, Hyderabad by the service provider through "Payment Gateway Service on e-Procurement platform".

1. Submission of Tender:

The tender is to Supply, Installation, Commissioning, Operation and Maintenance of Super Structure for Convocation Works at Rayalaseema University, Kurnool Andhra Pradesh. Tender is to be submitted through eProcurement website: www.apeprocurement.gov.in in two separate bids (Two bid system) **Technical bid** [*EMD* of Rs.20,000/- (refundable) and DD for Rs. 1,000/- towards application cost (non-refundable). If downloaded form is used] and **Financial bid** (Amount quoted as per financial bid).

Also, a copy of the tender documents in the form of two bids are to be submitted in separate sealed covers addressing to: **The Registrar, Rayalaseema University, Kurnool, Andhra Pradesh-518007** before placing both in ONE envelope and to be super scribed with "Arrangement of Super Structure for Convocation works". Tenders without Bid Security (EMD) shall be rejected summarily.

- 2. The EMD furnished should be valid beyond 30 days of the bid validity period and it will be forfeited if the bidder intends to withdraw the bid after opening the financial bid.
- 3. **Opening of bids:** The technical bid will be opened and scrutinized by the committee and the Technical qualification includes the scrutiny of documents submitted by the firm. The committee decision will be final in this regard. The financial bid of the technically qualified firms will only be considered /opened.
- 4. Each bidder should clearly specify that he agrees to / abide by the terms and conditions of this tender document on printed letter head/sign on tender document and attach it along with technical bid.
- 5. The bid should be accompanied by Bid Security/EMD of Rs.20,000/- may be paid in the form of crossed demand draft / pay order drawn Demand Draft drawn in favour of the **Registrar, Rayalaseema University, Kurnool** drawn from any Nationalised Bank payable at **Kurnool**. The E.M.D. of unsuccessful bidders will be returned after signing the agreement with the successful bidders.

- 6. The EMD of unsuccessful bidders will be returned without interest as per rules. The EMD of the successful bidder will be converted into part amount of Security Deposit and will be returned without interest after the successful completion of contract period subject to meeting the specified conditions as laid down by the University. The security deposit will be forfeited if any terms and conditions are contravened/deviated.
- 7. The interested bidders may download tender documents either from eProcurement website: www.apeprocurement.gov.in (or) the University Website: www.rayalaseemauniversity.ac.in.

 The cost of tender form of Rs. 1,000/- (non-refundable) may be paid by way of Demand Draft drawn in favour of the Registrar, Rayalaseema University, Kurnool drawn from any Nationalised Bank payable at Kurnool (DD is to be attached along with the downloaded tender forms).
- 8. The tender should be submitted on eProcurement website: www.apeprocurement.gov.in **by 5:00 p.m.** on or before **17**th **May, 2022.** Tenders received after the due date and time will not be considered by the University. The bid will be opened on the next working day at 11:00 **AM** in the presence of prospective suppliers (bidders) or their authorized representative. The representative should bring the authorization letter from their vendor for attending the tender opening committee meeting. If the opening day is declared as a holiday on account of unforeseen situation, it will be on next day.
- 9. The bids of black listed firm by any government organization as per knowledge of the University will not be considered. The decision of the University will be final in this regard.
- 10. The University reserves all the right to reject or accept any tender without assigning any reason or cancel or withdraw the tender notice.

Terms & Conditions:

- 1. The expenditure on the work shall not exceed the amount of Administrative Sanction.
- 2. Necessary Photographs shall be taken before grounding the work and after the Completion of work.
- 3. There shall not be any duplicate of the work under any other contract.
- 4. The work is to be awarded as per Government Norms.
- 5. The Work should be grounded within 5 days from the date of issue of Administrative Sanction.
- 6. The funds will be released based on the progress of the work.
- 7. During the course of execution any deviation is raised, it should be got Approved by the University immediately.
- 8. Every Bidder should enclose a DD Rs.1000/- towards Tender Fees along with Tender Document. The amount will not be refundable.
- 9. The Bids must be submitted on eProcurement website: www.apeprocurement.gov.in and a copy of tender document shall be submitted to the Registrar, Rayalaseema University, Kurnool not later than 17:00 Hrs (IST) on 17th May, 2022
- 10. Incomplete Tenders, Conditional Tenders and Late Tenders will be rejected straight away;
- 11. The suppliers shall quote the reasonable and competitive prices.
- 12. The items listed are considered as with high consumption and the bidder who has quoted overall L1 price for Items" will be awarded Rate Contract.
- 13. Income tax @ 2% will be deducted from the payments if the bidder is a company / firm. If the bidder is an indiduval sole proprietor, income tax @ 1% will be deducted and TDS Certificate will be issued by Rayalaseema University, Kurnool.

- 14. The Bidders are advised to be conversant with the terms & conditions as stated above before accepting the Contract.
- 15. <u>Fall Clause</u>:- In case, the Contractor supplies the items as specified in this contract at a lowest price to any other party, during the period of Contract, that lowest price will be applicable to this Contract also;
- 16. **Risk Purchase:** If the Contractor fails to supply the requisite quantity/ quality of the material, Rayalaseema University is at liberty to purchase such items from the local market to meet their requirements and claim the difference in price on higher side from the Contractor / deduct from the bills on hand.
- 17. There should not be any correction / overwriting in the Tender. Correction, if any, should be encircled in red ink and initialled by the bidder and **Corrections without initials, results in rejection of bid.**
- 18. The prices mentioned in the Contract are firm and fixed and no request for increase of price will be entertained during the period of the Contract.
- 19. In all the above conditions, the decision of the REGISTRAR, RAYALASEEMA UNIVERSITY, KURNOOL shall be final and binding.
- 20. In the event of any dispute arising out of the tender such dispute would be subject to the Jurisdiction of the Civil courts within the city of Kurnool.
- 21. The Prices quoted by the bidder shall be inclusive of all taxes and duties (i.e., GST etc.)

SETTLEMENT OF DISPUTES

- 1. Any difference or dispute arising out of or in connection with this tender or acceptance thereof or the contract that may be entered in consequence thereof, shall be decided by arbitration. The Registrar, Rayalaseema University, Kurnool or his nominee shall be the sole arbitrator and the arbitrator's decision shall be final and binding on the parties. The Tenderer(s) will have no objection to such appointment on any ground whatsoever including that such nominee, in his official capacity dealt with this matter at any stage.
- 2. The parties hereby agree that in the event of any dispute no cause of action shall arise in their favour to approach any court unless they have resorted to and exhausted the remedy of arbitration as envisaged above.
- 3. The parties also do hereby agree that the contract envisaged by these terms and conditions shall be deemed to have been entered into at Kurnool alone will have jurisdiction to try and legal proceedings which may arise out of this contract. Neither party shall file any proceedings in any other court.
